The National Company Law Appellate Tribunal (NCLAT), Chennai Bench, via its order dated June 16, 2026, has permitted the Appellants to **withdraw Company Appeal (AT) (CH) No. 57/2026**, resulting in the appeal being "**dismissed as withdrawn**".

(Respondents) an Appeal against the Scheme of Amalgamation ("Scheme") approved by the Hon'ble National Company Law Tribunal, Hyderabad Bench-1 at Hyderabad dated 24-02-2026 and 27-03-2026 The litigation is filed to Hon'ble National Company Law Appellate Tribunal (NCLAT), Chennai Bench (case details: Company Appeal (AT) (CH) No. 57/2026 (IA Nos. 792, 793 & 794/2026))
2	Brief details of the disputed litigation	The appeal was originally filed to challenge an NCLT Hyderabad Bench order dated February 24, 2026, which had rejected objections filed against the proposed scheme of amalgamation under CP(CAA) No. 35/230/HDB/2024. Because the main Company Petition was already decided on merits on March 27, 2026, the Appellants requested to withdraw this appeal. The NCLAT has officially dismissed the appeal as withdrawn , reserving the Appellants' rights to contest the final decision of the main petition.
