Subject: Response to Query: Observation - Regulation 23(9) - Starlite Global Enterprises (India) Limited

Dear Sir / Madam,

This is with reference to your communication dated 23-06-2026 requesting proof of submission of the Related Party Transactions (RPT) disclosure on May 28, 2026, and referencing the second proviso to Regulation 23(9) of the SEBI (LODR) Regulations, 2015.

We would like to submit our legal interpretation and clarification regarding the timeline followed by the Company:

Legal Interpretation of "Date of Publication"

The second proviso to Regulation 23(9) states that the listed entity shall make RPT disclosures "*every six months on the date of publication of its standalone and consolidated financial results...*"

We would like to inform you that we interpret the "date of publication" strictly in accordance with Regulation 47 of SEBI (LODR) Regulations, 2015, which governs the public dissemination of information.

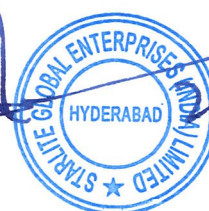
- **Date of Submission vs. Date of Publication:** The Board Meeting was held and financial results were *submitted/*filed to the Exchange on May 28, 2026. However, this constitutes the date of *intimation/submission*, not publication.
- **Newspaper Publication Timeline:** Pursuant to Regulation 47(3), financial results must be published in newspapers within 48 hours of board approval. The Company's results were officially published in the newspapers on May 30, 2026.

Consequently, the "date of publication" of the financial results to the public was on May 30, 2026. We have sent the newspaper publication for May 29, 2026 but due to some unavoidable circumstance, the newspaper was published on May 30, 2026 which as per the time limit mentioned in Reg 47 of SEBI (LODR) Reg. 2015

So, as per the our understanding the Timeline of RPT Disclosures shall be on the publication of financial results on newspaper which was May 30, 2026 and we have filed May 29, 2026 which is prior to that day. Due to XBRL filing of financial results which includes RPT. Otherwise, we have filed the alignment with actual publication of the result. The Company submitted the RPT disclosure PDF to the Exchange, perfectly matching the date the results appeared in the public domain via website and newspaper publication.

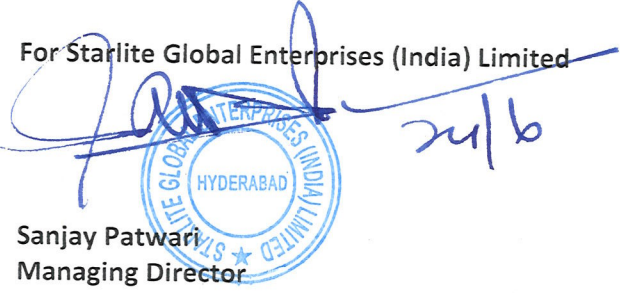
As the standalone RPT disclosure was legally and intentionally tied to the newspaper publication date rather than the board meeting filing date, no disclosure was executed or required on May 28, 2026. Therefore, a submission receipt for May 28, 2026, does not exist.

The Company has strictly complied with the spirit and letter of Regulation 23(9) by ensuring the RPT data went live alongside the public publication of its financial result.

We request you to kindly accept this explanation and take our submissions on record.
